Pursuant to the Article 56 of the Law on Higher Education ("Official Gazette of RS", No. 32/2012, dated 4.5.2012, UPB7 ZViS and relevant amendments /UPB ZViS – officially revised text of the Law on Higher Education, translator's comment/); acting upon an application of Doc. Ana Lasic for reelection to the position of the Assistant Professor for Film and Television Screenplay dated 1.7.2016; subject to the Article 211 of the Statute of the University; in accordance with the criteria for the appointment of University lecturers, scientific workers and associates of the University of Ljubljana dated 25.10.2011 (and all relevant amendments), and pursuant to the decision made in the 12th ordinary meeting session of the Senate of the Academy of Theatre, Radio, Film and Television, UL /University of Ljubljana, translator's comment/, dated 6.10.2016, I hereby adopt the following

DECISION

1. **Doc. Ana Lasic**, born on 8.1.1972
is hereby **relected**
to the position of the **Assistant Professor**
for Film and Television Screenplay
for a five-year period from 6.10.2016 to 6.10.2021
2. No costs were incurred during this procedure.

Reasoning

On 1.7.2016, Doc. Ana Lasic filed an application for reelection to the position of the University teacher - Assistant Professor for Film and Television Screenplay.

On 8.7.2016, on the 10th meeting session the Senate of UL AGRFT /Academy of Theatre, Radio, Film and Television, translator's comment/ appointed a Committee for evaluating professional competency of the relevant candidate to be reelected to the position of the University teacher - Assistant Professor for Film and Television Screenplay, composed of the following members:

PhD Doc. Blaz Lukan, Associate Professor PhD Igor Korsic and Associate Professor Miram Miosic (external member, ADU Zagreb /Academy of Dramatic Art, translator's comment/).

On 6.10.2016, based on positive professional evaluations made by committee members and on the positive opinion of the SS AGRFT /Student Council of AGRFT, translator's comment/ the Senate of UL AGRFT made a decision in its 12th ordinary meeting session on the reelection of Doc. Ana Lasic to the position of Assistant Professor for Film and Television Screenplay.

No costs were incurred during this procedure.

Legal remedy:

Doc. Ana Lasic may file an appeal to the Senate of the University of Ljubljana, Kongresni trg No. 12, Ljubljana, within the period of 15 days after the receipt of this decision. The appeal should be filed with AGRFT, Nazorjeva Street No. 3.
